

VIEWPOINT from your Business Manager Doug McKay

Eight months of negotiating with BC Hydro, and, in reality, the Public Sector Employers' Council, has resulted in a tentative agreement, reached in early December. Your Bargaining Committee members went to the wall for this round of negotiations and I am very proud of the hard work and dedication they put forward in achieving wage increases, benefit improvements and restarting the BC Hydro/IBEW Labour Forum.

For members working at BC Hydro, voting packages are being mailed in mid-December and you must return your ballot by mail by the date indicated in the package. The results will be announced in mid-January and the Bargaining Committee is recommending acceptance.

These were difficult negotiations and I look forward to the next round of bargaining in 2014 when we will hopefully have a government who understands the value of and respects our union members who put their lives on the line and work hard every day to keep the power on in this province.

Negotiations are now set to commence for our members working at a number of traffic control companies as their contracts expire. Safety on the job is a primary concern for our members in traffic control and we look forward to these negotiations.

For members working in the powerline utility, I pointed

out in the last issue of the Hotline the seriousness of violating safety rules and the consequences that can follow. I am going to repeat myself for the benefit of those who aren't listening – when you deal with electricity, there is no rational reason to take a shortcut – the result can be death, dismemberment or disability. And not just for you, but for those you work with.

When you became a member of this union you swore


IBEW Constitution

Article XXV: Misconduct, Offenses and Penalties

Sec. 1 Any member may be penalized for committing any one or more of the following offenses:

... (g) Wronging a member of the IBEW by any act or acts (other than the expression of views or opinions) causing him/her physical or economic harm.

... (o) Failure to install or do his/her work in a safe, workmanlike manner, or leaving work in a condition that may endanger the lives or property of others, or proving unable or unfit mentally, to learn properly his (her) trade.

an allegiance to the IBEW Constitution. That Constitution contains provisions where you can be charged if you are found guilty of “wronging a member of the IBEW by any act or acts causing him/her physical or economic harm.” These are serious words and have been put there for a reason. I cannot go to bat for you as a union member if you have intentionally broken the safety rules and I will stand by our Constitution to bring the charges and enforce the penalties for misconduct and offenses when it comes to safety if you have intentionally violated the rules.

It was good to have a strong delegation of IBEW members gather for the BC Fed convention and I thank all of those who participated. Sister Michelle Laurie did an exemplary job of campaigning for president of the BC Federation of Labour and now we all must move forward to face the challenges before us.

I am very disappointed to report that Bill C-377 was passed in Parliament and is now heading to the Senate. We have one last opportunity to turn this monster around - but I don't have much hope. We'll see what the new year brings as union workers continue to be attacked here in Canada and with more Right-to-Work (for less) legislation being passed in the USA. The battle has now taken a new turn with C-377 and we may need to do more than sign petitions and write letters to our MPs. 2013 may just be the year for serious political action, on a number of fronts.



Local 258 IBEW Dispatch Services

Local 258 IBEW offers a Dispatch service for members who are unemployed and are eligible to work (via their trade qualifications) with BC Hydro and Local 258's outside line contractors.

Members are not allowed to accept jobs directly from employers hiring Local 258 members without first obtaining clearance from Dispatch. If you look for work with a Local 258 employer and are hired without getting clearance from Dispatch at Local 258, you may be pulled from the job and fined by the union.

To be eligible for dispatch, please note the following:

It is up to each Local 258 member to sign up to the dispatch list as soon as you are unemployed. Do not delay, as this will affect your standing on the list. Members are called out to work based on a combination of criteria, including trade qualification, union seniority and date of when you called Dispatch to register.

Procedure for Placement on the Local 258 Dispatch List:

1. Your membership in Local 258 must be current - you must be an Active Member with membership dues paid and up-to-date.
2. It is helpful if you submit a resume including your qualifications and work history, copies of trades qualifications and/or tickets you have. If you are a Journeyman, you must have an Interprovincial

Red Seal for applicable trades only.

3. We must have your current contact information, including phone number and full mailing address. Please update your contact information on a regular basis if there are changes, as this impacts our ability to provide you with work opportunities.
4. You must provide copies of your current regular and/or special drivers license.

Please send all of the above required documents - resume, current contact information, copies of trade certificates and drivers licenses PLUS A CHEQUE FOR \$56.50 - via regular mail to IBEW Local 258, ATTENTION: DISPATCH, 7535 Sixth Street, Burnaby, BC V3N 3M2. If you live in the lower mainland area, you can personally deliver these documents directly to the Dispatch office at the union's headquarters.

Tentative agreement reached for members working at BC Hydro

Following eight months of intense negotiations, the Bargaining Committee for Local 258 IBEW has reached a tentative agreement for members working at BC Hydro.

Local 258 IBEW Business Manager Doug McKay says, “It has been a tough round of negotiations since the contract expired at the end of March of this year. Our bargaining committee was faced with many challenges from this employer and we worked very hard to achieve fair wage increases. We were able to protect our benefits package and negotiate a number of modest improvements for our members working at BC Hydro – and we achieved these improvements across the board for all of our members working at BC Hydro, no one was left behind.”

Highlights of the tentative agreement include:

- 2% wage increase retroactive to May 1, 2012
- 2% wage increase effective August 1, 2013
- an increase in the living out allowance
- improvements to the benefit package for prescription eyewear and protective footwear

The union also agreed to a two-year employment commitment for apprentices who begin training in 2013.

“Thank you to the members who stood strong and were determined in rejecting the concessions and unreasonable proposals brought to the table by this employer,” says McKay.

Union set to commence Traffic Control bargaining

With a number of collective agreements expiring in November and December of 2012, members working in Traffic Control have been sending in their bargaining proposals as the union prepares to commence negotiations.

Local 258 IBEW Assistant Business Manager (ABM) Dan Klassen and Acting ABM Nicole Biernaczyk report many members are looking forward to this round of bargaining to deal with a number of issues in the contract and to negotiate wage, working conditions and benefit improvements. “Many of our members have stepped forward to participate on bargaining committees for their workplaces and we look forward to strong rounds of negotiations with our Traffic Control employers,” says Sister Biernaczyk.

Contracts expiring at the end of November or December 2012 include:

- Island Traffic, based in Sidney, BC
- Valley Traffic, based in Langley, BC
- High Voltage Traffic Control
- Traffic Pro, Abbotsford
- ATC Traffic Management

Retroactive to May 1, 2012 and subject to a ratification vote with a mail-in ballot, details and a voting package will be mailed to members in mid-December. Results of the vote will be announced in mid-January, 2013.

IBEW 258 members help our southern neighbours with the effects of

Hurricane Sandy

Many Local 258 members quickly mobilized to the urgency of Hurricane Sandy as the late October forecasts predicted one of the worst storms in US history was heading to the north-east coast of the USA and the heavily populated states of New York, New Jersey and surrounding areas.

From Mike Scott at Allteck: This was the third time Allteck has worked storm on the east coast of the US.

In 2011, Allteck sent crews to respond to September's Hurricane Irene and then to the freak Halloween snow storm that left 3 million Americans out of power.

This year, I had the privilege of leading Allteck's crew of 44 line workers as we left for Connecticut on October 26, 2012. Our crews were on the ground ready to respond in Connecticut Light & Power (CL&P) trucks when

Sandy made landfall.

During the massive hurricane, our crews were only able to respond to wires down across roads and we cleared the roads so emergency responders could get through. The winds were extreme, breaking massive trees like matchsticks and the rain seemed to be coming in sideways from every direction.

Our crews worked safely and efficiently restoring power to thousands of people left in the dark after Sandy's wake. For two weeks we moved from East Hampton down the coast to a town called Madison, 40 miles from New York City.

Our guys wanted to let people know that we were Canadians so they used phasing tape to add "Team Canada" or "Eh Team" logos on their trucks! We are proud "BC boys" and have earned a reputation from the local residents as the "Canadian Cavalry"!

Our crews displayed their skill and the dedication to the trade that IBEW 258 members are known for. We brought smiles and, more importantly, light and power to people who were in desperate need of help.

I am a proud member of Allteck's "Team Canada" and proud of the work our IBEW 258 members did. 🇨🇦

I just wanted to drop a quick line to say thank you very much for sending a team to Connecticut to assist with getting the power back on after Hurricane Sandy.




My brother and his family live there. About this time last year, they were hit by a massive snow storm and he and his young family went without power for four days.

Largest delegation of IBEW members in history attends 2012 BC Federation of Labour Convention

The International Brotherhood of Electrical Workers had a strong delegation at the 2012 BC Federation of Labour Convention that took place in Vancouver the last week of November. With 65 delegates attending from Locals 258, 213, 230, 993 and 1003, IBEW sent it's largest delegation in history to the 55th gathering of labour activists from across the province.

Showing their support for Local 258's Michelle Laurie as she campaigned for



election as the president of the BC Federation of Labour, the IBEW delegates participated in all aspects of the convention, from speaking to resolutions to attending the rally to engaging in discussions about many important labour issues.

Guest speakers included Burnaby Mayor Derek Corrigan who spoke about his support for the labour movement. Young activist Brigitte de Pape, best known for taking a stand while working as a Page in Parliament with her "Stop Harper!" sign, engaged delegates with a call to action to "take BC and then take Canada" as she was supported by dozens of members of the Young Workers Committee.

Journalist and best-selling author Linda McQuaig took to the stage and gave an enjoyable and informative speech based on her recent book, "The Trouble with Billionaires".



BC NDP Leader Adrian Dix roused delegates with a moving speech on Wednesday and Tom Mulcair, leader of the federal Official Opposition New Democrats activated delegates on Thursday.

Canadian Labour Congress President Ken Georgetti addressed delegates as well.

Bill C-377 passed by Harper Conservatives in Parliament – now heads to Senate

As the Hotline goes to press, Bill C-377 was passed by the Harper Conservatives in a fairly close vote of 147 to 135 on 12/12/12.

The Private Members Bill, strongly backed by well-known anti-union organizations, aims to place unnecessary financial burdens on labour unions and threatens privacy regulations. It will cost Canadian taxpayers millions of dollars and will more than likely be headed to the courts and found to be illegal and unconstitutional.

Testimony by the Canadian Bar Association, the Privacy Commissioner of Canada, and other authorities warn that C-377 encroaches on provincial jurisdiction, violates privacy rights, threatens freedom of association under the Charter of Rights and Freedoms, contravenes provincial privacy laws, and poses a clear threat to commercial privacy and private business practices.

When first introduced in the House of Commons, this flawed piece of legislation was ruled unacceptable because of legal errors (the sponsor, MP Russ Hiebert of White Rock, didn't understand what he was doing). Now, despite the introduction of last-minute amendments -- there are more pages of amendments than there are clauses in the final proposal -- issues of constitutionality, privacy and Charter rights remain.

Both the Canada Revenue Agency and the Parliamentary Budget Officer were asked to estimate the cost to set up and operate the new government program C-377 would create. Both agree that the provisions of C-377 are too unclear to provide a reliable guess of the cost to taxpayers.

Over two reports, the CRA has estimated set-up costs ranging from **\$2.4 million and over \$20 million.**

Operating costs were pegged at less than \$1 million each year in one report and at just under \$4 million per year in another. However both reports assume that C-377 requires less than 1,000 reports be

submitted every year. There are currently more than 25,000 unions, union locals and organizations who will be forced by this legislation to report.

The Parliamentary Budget Officer says C-377 is so nebulous that the costs cannot be guessed at this time, although he contends that the CRA has seriously underestimated the costs by underestimating the number it could process (he suggests over 18,000 reports).

In the United States, the government department that manages its electronically-filed union financial reporting had a budget of \$41.29 million and 249 full-time staff in 2012 and has requested a budget of \$41.77 million to operate through 2013. It represents a more realistic picture of what a new division at the CRA would require to collect, audit, and administer the volume of highly detailed reports each year from Canada's more than 25,000 unions, locals, lodges, councils, etc.

The bottom line for MPs is that C-377 has a history of unpleasant surprises, from mistakes in drafting to fundamental misunderstandings of the entities it intends to regulate. Handing taxpayers a multimillion dollar boondoggle at a time of deep budget cuts and government promises that the priority is to "create jobs and growth" is a risk not worth taking.

A decade of disastrous energy policy decisions need to be reversed if our public utility is to thrive

Most of us spend little time thinking about where our electricity comes from or the policies and politics behind it. We just flick on the switch and the light goes on; we turn on the tap and the water is hot.

British Columbians are fortunate to have an abundance of natural resources, including our access to clean, reliable electricity. Over ninety-three per cent of the province's electricity comes from hydro, an enviable position in an emerging carbon-constrained economy.

But how much longer will we be able to maintain that position?

Over the last decade the BC Liberal government has undermined much of what made BC Hydro a dominant utility in North America. In doing so they have undermined our province's competitive advantage of low-cost, low-carbon electricity.

Ratepayers expect decisions involving BC Hydro will be made in the public interest. Unfortunately, BC Liberal energy policy severely restricts BC Hydro from building new generation, forcing the crown agency to purchase power from private for-profit companies at inflated prices. The policy also prohibits BC Hydro from storing water and purchasing electricity on the open market when prices are low.

This already bad directive was made worse by the Liberals' "Clean Energy Act," which formalized an artificial "self-sufficiency" requirement defined by a 50-year drought water level, plus a massive insurance requirement of an additional 3000 GWh. With these directions from the Liberal government, BC Hydro signed long-term contracts for this power at locked-in, take-or-pay rates that are many times higher than the spot market price for freshet power.

We saw the ultimate result of these deals last spring, when we lost at least \$180 million dollars with BC Hydro buying private power at a cost averaging \$68/MWh, when the average open market price averaged \$10/MWh. Worse, much of that seasonal power wasn't even needed to meet demand. At a time when we were spilling water over the top of our publicly owned Peace Canyon dam, we bought private power at almost seven times higher than the market price.

This kind of instability is not good for British Columbians or BC Hydro. More troubling, the Liberal policy centralizes decision-making with politicians in the cabinet and cuts the independent BC Utilities Commission out of the loop.

These Liberal policies have undermined the BC Hydro work force, dramatically increased debt and deferral accounts and has resulted in double-digit rate increases on hydro bills. It's a lose-lose situation.

BC New Democrats are working on a plan to restore confidence at BC hydro and ensuring that all British Columbians continue to benefit from a strong public utility.

Four main principles should guide energy policy: Put conservation and environmental protection first; maximize the public benefit by encouraging community-based energy solutions that create jobs, economic development and revenue for social programs; keep a strong BC Hydro at the centre of renewable energy development and generation; and keep rates affordable for both industry and consumers.

BC Hydro has been put in a very precarious position by the constant political meddling and poor decision making that has been the hallmark of BC Liberal energy policy.

Putting our provincial utility back in order will be one of the highest priorities of an Adrian Dix New Democrat govern-

ment. We will open the books, bring back the oversight role of the BC Utilities commission, and do our best to mitigate the impact of contracts the Liberals signed that are not in the public interest.

We understand the vital role that BC Hydro plays, not just in delivering clean, reasonably-priced energy to BC families, but in promoting industrial development and in making our province an attractive place to invest.

From the very beginning it was clear that the Liberals didn't understand how vital it is to maintain BC Hydro as a strong public electricity utility.

New Democrat leader Adrian Dix is offering a change for the better, one practical step at a time.

We know government can't do everything, but it has to get the fundamentals right. That means putting the needs of British Columbians before narrow political interests, and making sure everything we do is aimed at making life better and more affordable for our citizens. 🇺🇸

The delegates of the 38th IBEW International Convention, which was conducted in Vancouver, British Columbia, Canada, during the week of September 19 through 23, 2011, approved several amendments to Article IX of the IBEW Constitution. Accordingly, effective January 1, 2013, there will be an increase of one dollar (\$1.00) for the IBEW Pension Fund Benefit, which applies to "A" members only. There will be no change to the per capita that is paid to the General Fund, and therefore, the rate for all "BA" members shall remain the same. The following rates will apply to the I.O. portion of all monthly dues payments for January 2013, and thereafter:

RUMINATIONS OF A RETIREE

It is December so this must be sunny southern California. When we left home at the end of October it was cool and rainy. We travelled for three days and a little over 1000 miles before the rain stopped and we found some sunshine. While we were driving through the rain there was always a band of brighter sky on the horizon ahead. I kept thinking that we would soon be enjoying sunny weather. Even when we crossed into California it was still raining and the bright sky was just ahead tantalizing us. Our perseverance was rewarded on the fourth day and sunny weather was achieved. Since we arrived at our desert home sunny southern California has performed as advertised with daily sunshine and temperatures around 26 to 28 Canadian degrees. The weather persons on TV are telling us that a cooling trend is on the way and by the weekend the temperatures will plunge to 20 to 22 Canadian degrees. It appears that winter is just around the corner.

With this being December and winter just around the corner the Christmas frenzy is in full swing. We have already weathered the US American presidential election and Thanksgiving with the attendant "Black Friday" shopping event. The weekend newspaper comes complete with 20 pounds of glossy advertising flyers enticing us to buy all sorts of merchandise. Well, 20 pounds might be a bit of exaggeration. It just feels like 20 pounds when I have to carry it over to the recycle bin. It is probably not much more than 15 pounds of advertising copy. I wonder what all the save the trees people think of that method of marketing. With the six weeks or so of hype leading up to Christmas the day itself is kind of anticlimactic by the time we get there. I'm not really all "Bah, Humbug!" about Christmas. I just think a couple of weeks of preparation and Christmas carol music would be enough.

Past experience has shown that Christmas time generally brings folks over to visit. The imminence of company coming always requires copious amounts of dusting and cleaning and vacuuming. At this point I want to assure you that we do not reside in filth and squalor in our daily lives. I therefore wonder why, if the place is clean enough for us to live in on a day to day basis, we have to endure this cleaning regimen because company is coming. If it is good enough for me it should be good enough for them.

When it comes to cleaning we have established that I have the necessary qualifications for heavy lifting, washing windows and floors and vacuuming. I have been asked to not do laundry (something about the dryer and wrinkled clothes), I may not wash the ingredients for a salad (especially if company is coming) and any dishes I do are suspect and require further inspection. While not exactly cleaning, another area of household chores I apparently require remedial training in is putting the groceries away in the refrigerator and pantry. The few times I have taken the initiative to

store the groceries on my own have required a subsequent complete reorganization of refrigerator and pantry. It is always good to identify the limits of one's qualifications in such matters.

Still sort of obliquely relative to cleaning is the organization of our shed. The shed is a 10' by 10' structure that takes the place of a basement or garage in a normal house. I therefore submit that the shed should be a guy domain where things can be left scattered around close to hand and not subject to the same organizational requirements as the house. Well, in our case, a park model trailer sort of a house. Anyway, the shed has a work bench and sundry tools and equipment including, but not limited to, garden implements, nuts, bolts, screws etc. as well as such other items that may now be unnecessary but are too good to throw away and may be of some use in the future. Unfortunately (for me) the shed also contains the laundry equipment (washer and dryer) which I have been asked not to use. Encroachment by other than guy personnel has therefore occurred. It may only be my perception but it seems that over the years the space and shelving allotted for storage and retention of the aforementioned guy stuff has been usurped to store and retain more mundane household items. From time to time these household items will be reorganized resulting in my inability to locate, without considerable searching, car care products or golf cart parts. Shed sharing requires ongoing discussion, negotiation and compromise.

While all this rumination about cleaning and sheds was going on, the same newspaper that provides 20 or 15 pounds of advertising copy had a story about a job fair held in Indio, California. It was reported that job seekers came from as far away as Arizona, which really isn't all that far, but the element of the story that caused a lot of rumination was that the work was in British Columbia, Canada where there are 40,000 unfilled jobs. It was further reported that there were 2000 companies represented along with people from the British Columbia Construction Association and the BC Ministry of Jobs, Tourism and Skill Training. Having been away from BC for a month or so and therefore short on facts my rumination has been given free rein. It struck me that 40,000 is about the number of people in a small city. So, somewhere in BC there is a small city's worth of jobs with nobody to work at them. I would therefore imagine that everybody in BC is working and those not are being trained to fill the jobs. I also imagine that technical institutes and apprenticeships are operating above capacity to address the shortfall. Unfortunately for the California job seekers I am sure that the BC government and industry are working together at a fevered pace to supply trained and qualified BC workers for the small city's worth of unfilled jobs. At least that is what I imagine.

Sign up today on Local 258's website!



I went to Pemberton for a year, then to Dawson Creek and then to Kootenay Canal Generating Station near Nelson for a few years. I then got recalled to the apprenticeship starting in Kamloops for 2 1/2 years. When I topped out, I bid the North Shore in 1990 and am now working as the Foreman Lineman.

In 2002, when former union VP Murray MacDonald was heading into retirement, Brother Rick Klassen approached me while I was taking some classes at EITI and suggested I step forward and run for office in the union. It sounded interesting so I took the opportunity and the campaign was on! I was successful in getting elected as VP after a run-off election as we had four candidates vying for the position and I am now serving my third term.

Since becoming more involved with Local 258 and the broader labour movement as a whole, I've had a number of experiences that have opened my eyes to the real importance of unions in our communities. What I've seen is that unions aren't just there to negotiate collective agreements, provide strongly backed representation to members and support for one another in the workplace - unions help to shape our society with a strong middle class that contributes to a vibrant economy.

I take great pride in the accomplishments of our union, the IBEW. For more than a hundred years, we have represented millions of workers across North America, and together with the broader labour movement, have much to be proud of with our accomplishments. But we cannot ignore the fact that there are, and always have been, significant forces seeking to dismantle, divide and conquer our membership and destroy the strength we have when we stand together.


